A BILL FOR AN ACT

CONCERNING THE APPLICABILITY OF WILDLIFE PROHIBITIONS.

Bill Summary

(Note: This summary applies to this bill as introduced and does not necessarily reflect any amendments that may be subsequently adopted.)

Clarifies that a person who takes wildlife in compliance with a license, or in compliance with other restrictions on the time, place, and manner for such taking, does not commit illegal hunting, taking, possessing, or destruction of wildlife.

Establishes the level of culpability for the illegal selling or purchasing of wildlife to be the knowing sale or purchase of wildlife. Establishes the level of culpability for the illegal willful destruction of wildlife to be taking with the intention to abandon a part or all of the wildlife.

23	person in the illegal hunting or taking of any wildlife for the purposes of
24	monetary or commercial gain or profit.
