Routt Republicans Endorse Haggott

Complete harmony prevailed in the republican ranks at Hayden yesterday when delegates from various precincts in the county met for the purpose of selecting eight delegates to the state and congressional conventions at Pueblo on the 28th. There were no contests in any of the precincts.

The convention was called to order at 2 p. m. by County Chairman W. B. Wiley and J. M. Whetstone of Hayden and C. S. Merrill of Craig were chosen chairman and secretary of the convention. J. A. Coulter of Craig, D. P. Wilson of Steamboat and J. V. Solandt of Hayden were appointed as a committee on resolutions and reported as follows.

We, the republicans of Routt county in delegate convention assembled, congratulate the republicans of this county upon the splendid condition and record of the party in the state and nation. The great administration of President Roosevelt commends enthusiastic admiration and we recognize in him a worthy successor to Lincoln, Garfield and McKinley. We appreciate the fearlessness of our leader in abandoning the dead issues of the past and in grappling with the gigantic evils of the present.

We believe it will be to the best interests of our country if the policies inaugurated by President Roosevelt be continued, and this continuance will best be secured by the nomination and election of a man thoroughly conversant and in sympathy with these policies and we therefore endorse for the exalted position the Hon. William H. Taft.

We endorse the clean and able state administration of Gov. Buchtel as being one of the best and most satisfactory to the people in the memory of Colorado.

We endorse the local option law enacted by the last legislature and heartily support its principles as being just, fair, a protection to our homes and in harmony with the spirit of our constitution and principles of civil government.

We favor reasonable public improvements economically carried forward, free from graft in the interest of the taxpayers and only so fast as a growing and prosperous county demands and the majority of the people are willing to pay, and suggest the policy of not levying excessive taxes when our county is now free from debt creating a revenue of the people's money to be deposited in the various banks of the county, and by them loaned out at extravagant rates of interest and that the taxpayers do not receive any benefit from the same.

We further recommend to the succeeding republican convention that it use their best judgment in the selection of a county ticket who will serve the interest of the

people of Routt county as the present incumbents have done, showing that Routt county is the only county in the state that is free from debt with thousands to its credit.

Resolved that this convention recognize the faithful services rendered by the Representatives Geo. W. Cook and Warren A. Haggott in congress and at the proper time recommend their re-nomination as members of the 61st congress of the United States.

The report of the committee was adopted unanimously. The convention then selected the following delegates to attend the Pueblo convention: James Whetstone, C. A. Purinton, W. F. Teagarden, E. D. Smith, W. T. Laramore, L. D. Campbell, E. H. Godfrey and F. A. Metcalf.

Owing to the recent formation of the new Oak Creek voting precinct, the convention by vote decided to allow the precinct in the coming county convention one delegate at large and one other delegate, and that Egeria precinct be reduced one delegate, as this precinct was cut off from Egeria.

Some Business Changes

New deals all around this week. Rolla Kellogg and Frank Bower, who have had charge of the McLachlan saw mill under lease, have given up their lease and the mill will be run this season by Mr. McLachlan himself, and now Archie is happy once more.

Rolla Kellogg goes to Axial this week to take charge of the Hugus & Co. store at that place, and the post office which will be moved in with the store. Mrs. Kellogg will remain in Craig until school closes. While we regret to see Mr. and Mrs. Kellogg leave Craig, yet we realize the company could not have made a better selection for their Axial manager, and the Courier wishes him the best of success in his new position. Frank Bower will resume his former position at the mill with Mr. McLachlan.

Last week Range Rider Hurd and a representative of the mill looked over the government timber near the mill site and determined on the sale of 600,000 feet, which it is expected the mill will cut up this summer, together with some 100,000 feet yet standing on Mr. McLachlan's land, making in all about a million feet.

It is rumored that E. D. Smith of Hayden will move his mill to within three or four miles of the McLachlan mill, and will build a road from it to the Craig road. If this is done, Craig should not remain long in want of timber to build with.

By a Two-To-One Vote the People of Craig Decide to Incorporate the Town

GETS READY FOR THE RAILROAD BOOM

On Tuesday, April 21st, Craig decided to incorporate, the vote being nearly two to one in favor of the move. A total of 119 votes were cast, 79 for incorporation and 40 against. The move was started two years ago but at that time was considered a little premature and was not pushed to a vote. Now, the unusual activity along the Moffat line and the generally bright prospects for the town of Craig have convinced most of the people that the time has come when the town should govern itself. The next move will be the election of officers which will probably take place the latter part of May or early in June. This is the serious part of incorporating, and the people must see to it that our officers are elected from the substantial business men of the town, and no man should shirk the duties thrust upon him. Let our motto be: "WORK FOR CRAIG'S BEST INTERESTS. AND WORK ALL THE TIME."

Craig Wins High School Debate

The decision of the judges Saturday night awarded the debate to the negative, or Craig, side of the question; Resolved, That the government should own and operate the railroads. The decision was by a very close margin and both schools did themselves proud in their endeavors to win. The debaters were: Hayden Miss Ethel Wood, Wolcott Hooker and Everet Adair; Craig Willie White, Leon Breeze and Ralph White. With the exception of Ralph White and the rebuttal by Wolcott Hooker, the speeches were carefully prepared beforehand. Those two boys did remarkably well in their extemporaneous efforts.

Both schools have reason to feel proud of their representatives.

The judges were Mrs. J. G. McLaughlin, Mrs. H. B. Peck, Mrs. J. J. Jones, J. A. Coulter, Dr. Peteher and W. H. Rose.

The program rendered giving diversion from the logic of the debaters, was a very pleasant one, and the audience seemed to thoroughly enjoy it. Good work in entertaining was done by the two male quartettes, Oliver Tayler with his paper and the farce. The paper was unusually lively for a school paper and caused much merriment.

The next debate will be held about a year from this time at Hayden, and then it will be up to Craig to defeat the Hayden orators on their own grounds.
