

# December 2009 Taxes, Remitted in January 2010 Sales, Use, and Accommodation Tax Report

This City of Steamboat Springs Sales, Use, and Accommodation Tax Report examines tax collections for the month of December 2009, which were remitted to the City in January 2010.

## Sales Tax


December 2009 sales tax collections decreased 10.63% from sales tax collections for the month of December 2008. General Fund sales tax collections decreased 10.63%. Steamboat Springs Redevelopment Authority sales tax collections for December 2009 were lower than they were in the month of December 2008; and year-to-date remains below \$0.

Year-to-date total sales tax collections are 16.27% lower than those of 2008 year-to-date. General Fund sales tax collections are 14.90% lower, and Steamboat Springs Redevelopment Authority sales tax collections are below the 2004 baseline by \$462,209.








## **Building Use Tax**

December 2009 Building Use Tax collections decreased 86.80% from December 2008. Year-to-date building use tax collections decreased 60.60%.


