

## February 2010 Taxes, Remitted in March 2010 Sales, Use, and Accommodation Tax Report

This City of Steamboat Springs Sales, Use, and Accommodation Tax Report examines tax collections for the month of February 2010, which were remitted to the City in March 2010.

### Sales Tax

February 2010 sales tax collections decreased 3.04% from sales tax collections for the month of February 2009. Year-to-date total sales tax collections are 5.29% lower than those of 2009 year-to-date.

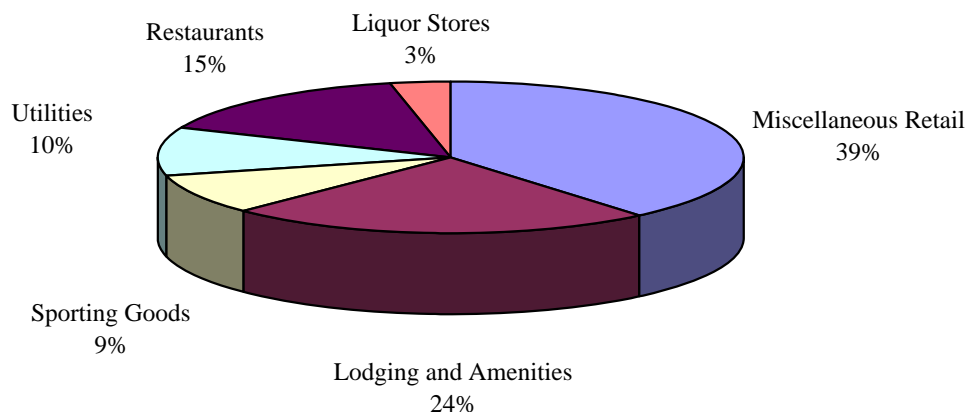

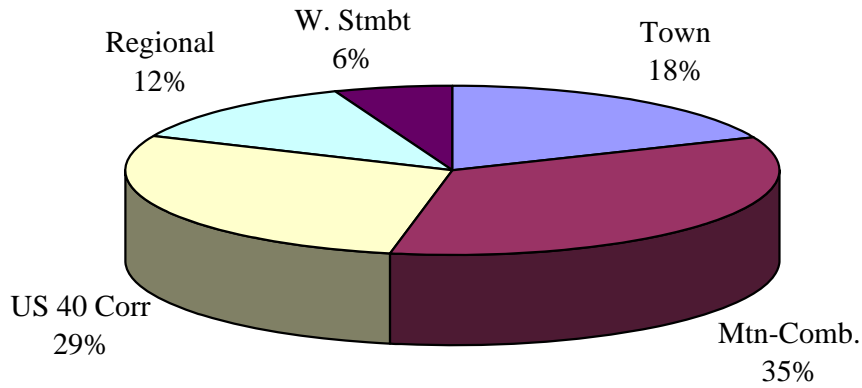

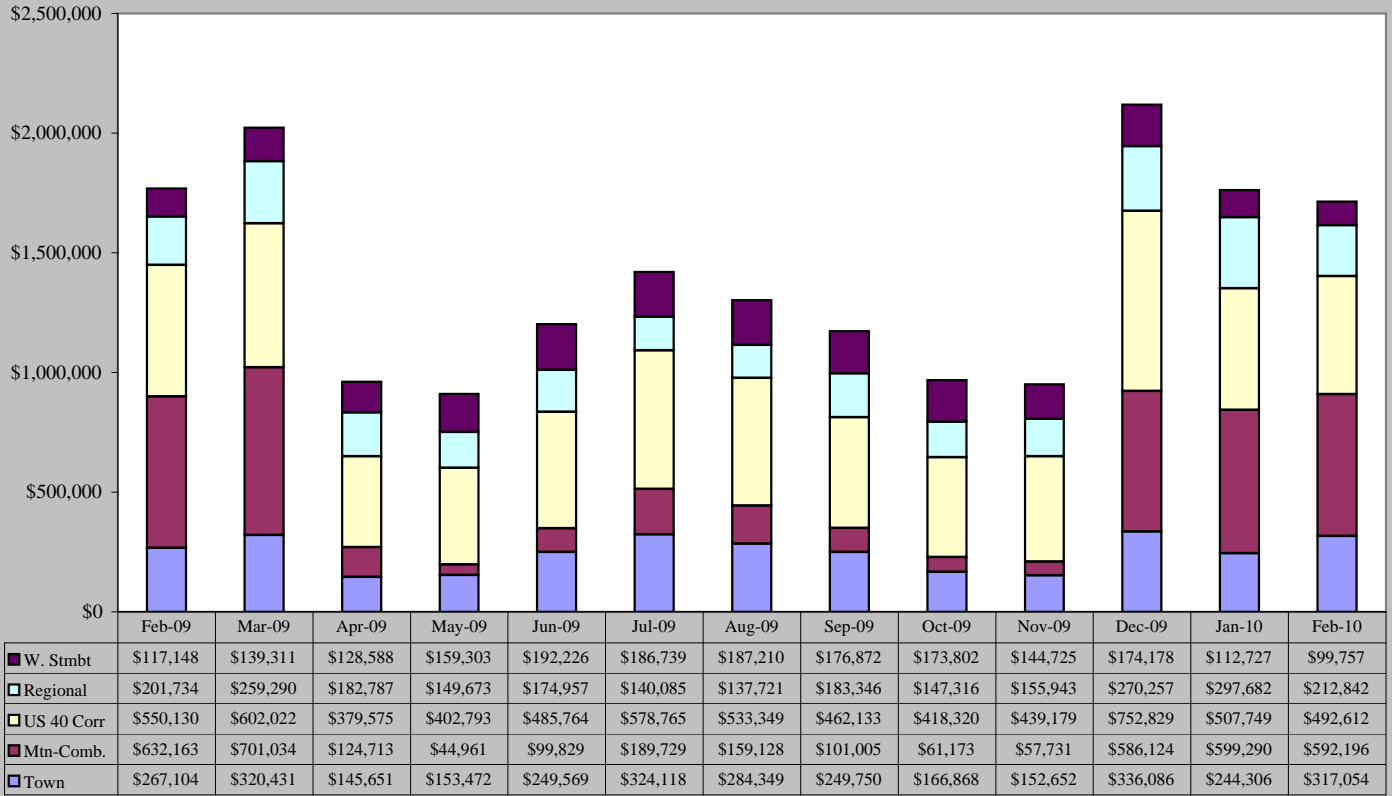




## February 2010 Sales Tax By Area

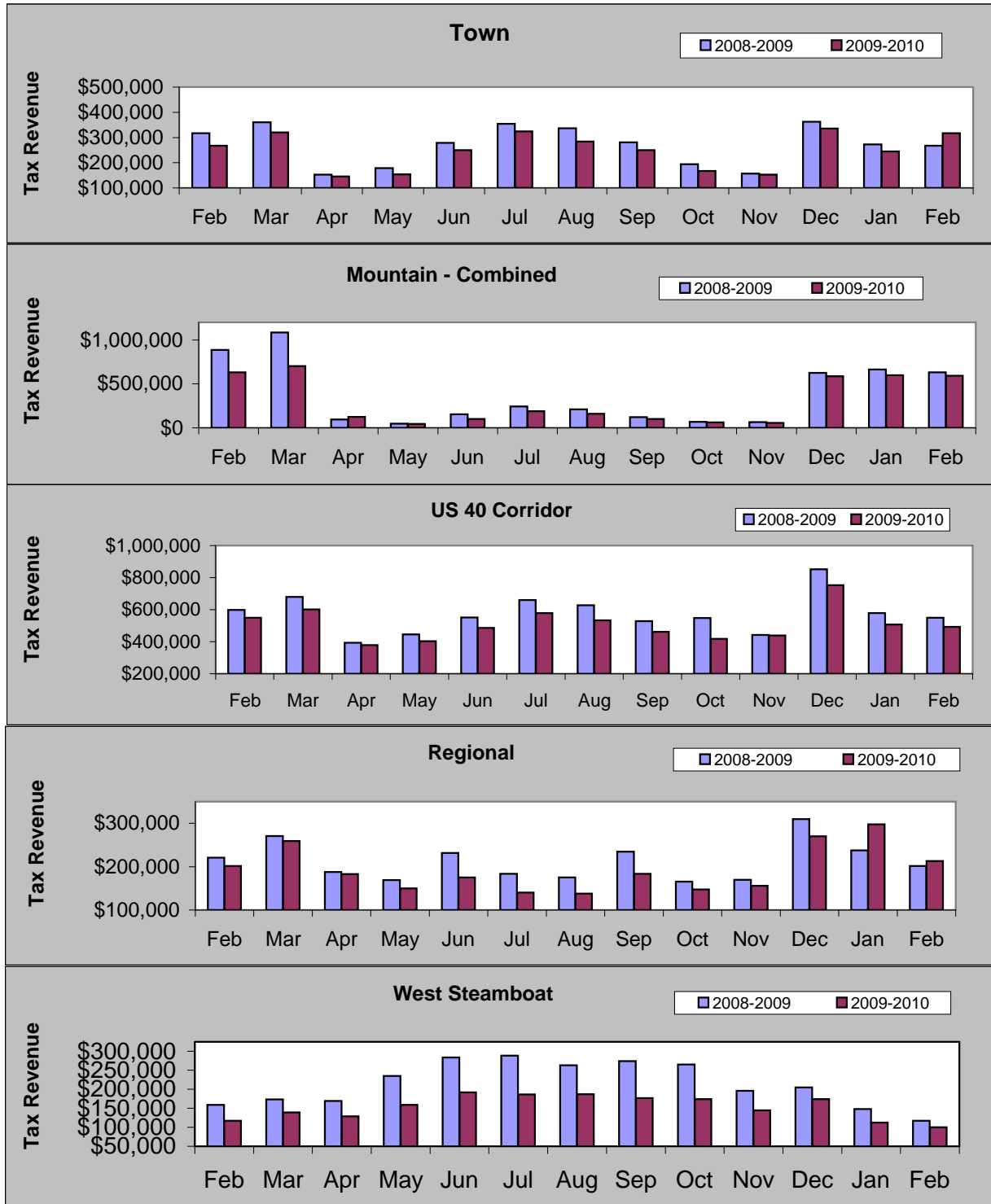

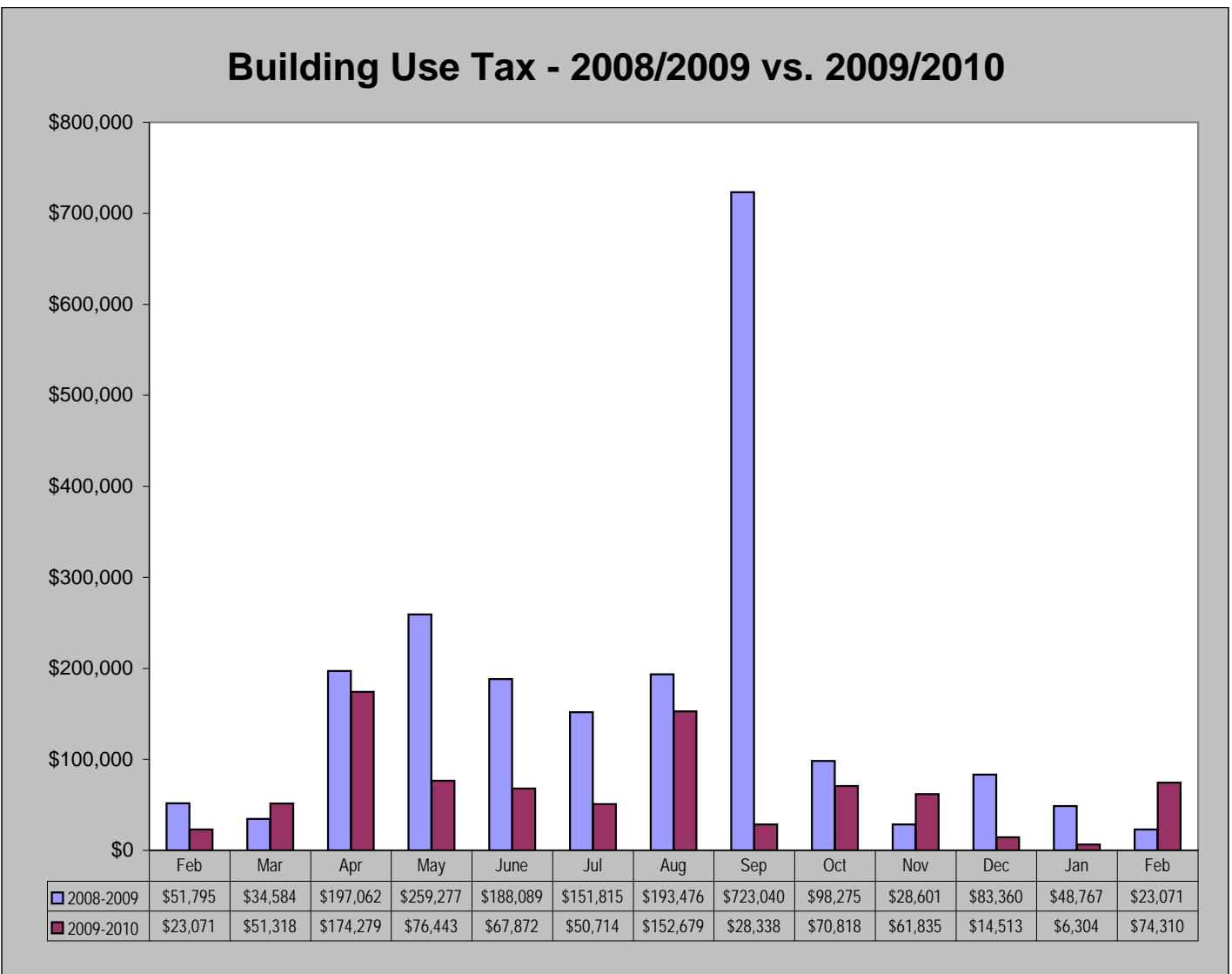
# Building Use Tax
