This City of Steamboat Springs Sales, Use, and Accommodation Tax Report examines tax collections for the month of April 2011, which were remitted to the City in May 2011.

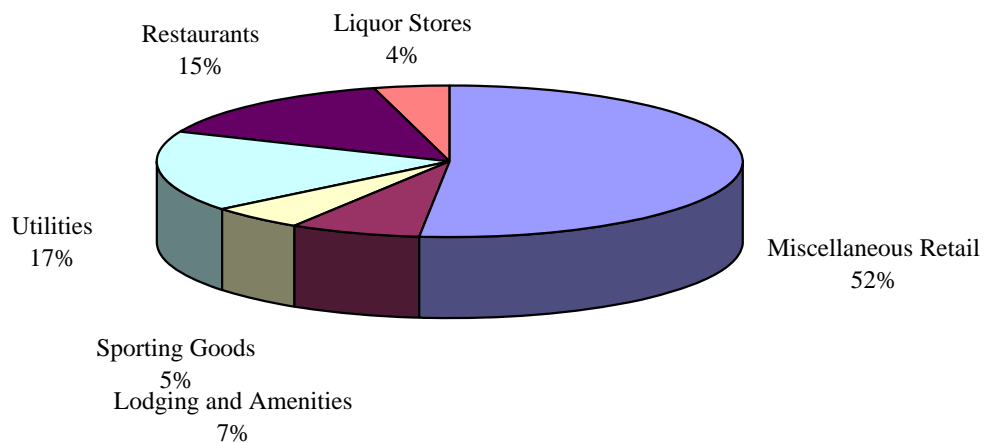
### Sales Tax

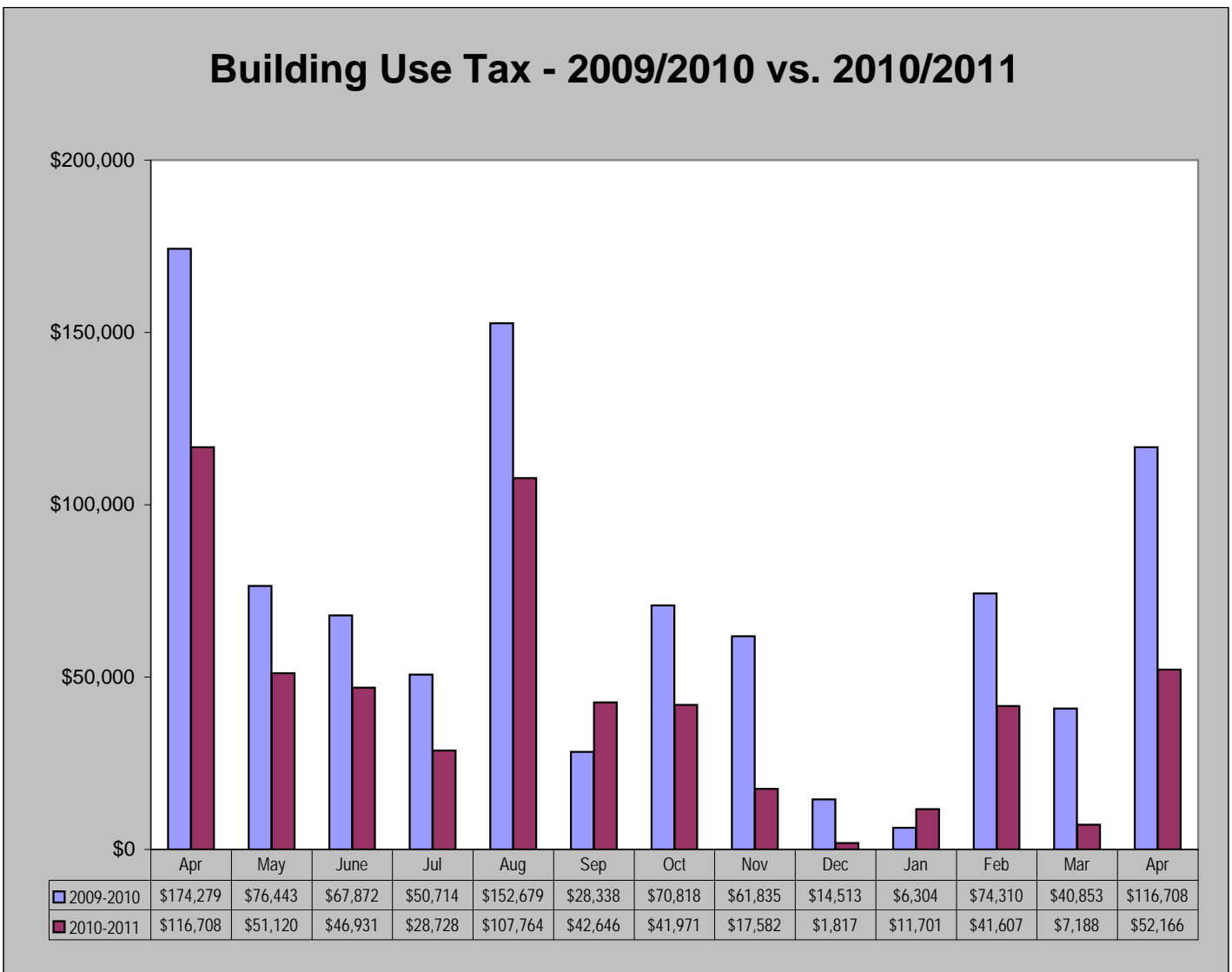
# Building Use Tax
