

# August 2011 Taxes, Remitted in September 2011 Sales, Use, and Accommodation Tax Report


This City of Steamboat Springs Sales, Use, and Accommodation Tax Report examines tax collections for the month of August 2011, which were remitted to the City in September 2011.

#### **Sales Tax**

August 2011 sales tax collections increased by 6.66% from sales tax collections for the month of August 2010. Year-to-date total sales tax collections are 3.75% higher than those of 2010 year-to-date.






## **Building Use Tax**




### **Accommodation Tax**
