February 2012 sales tax collections increased by 2.46% from sales tax collections for the month of February 2011. Year-to-date total sales tax collections are .85% higher than those of 2011 year-to-date.

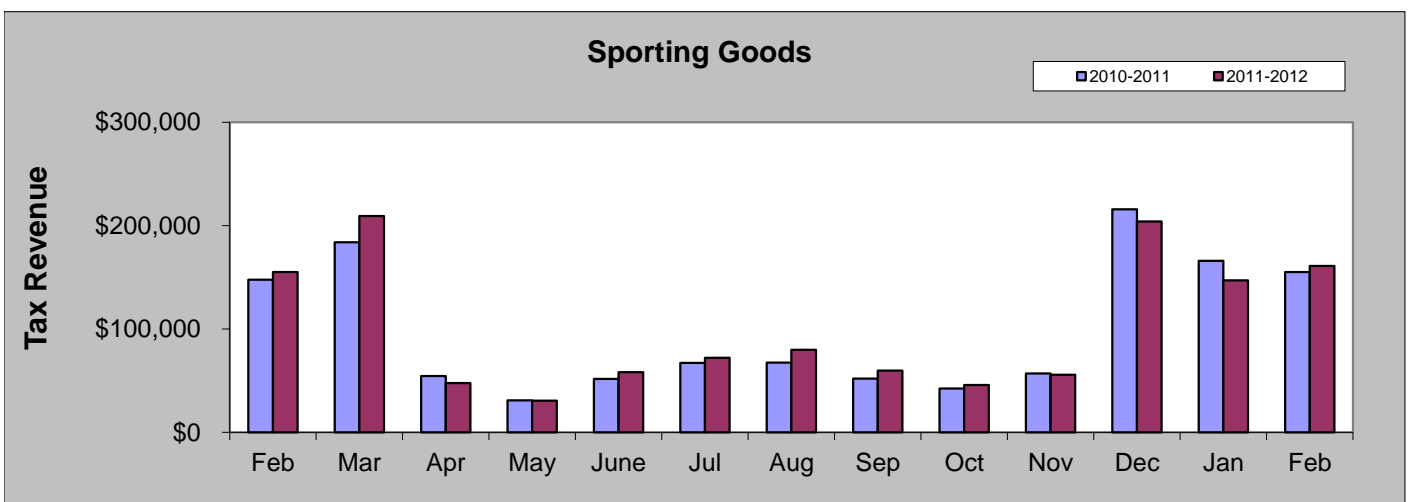

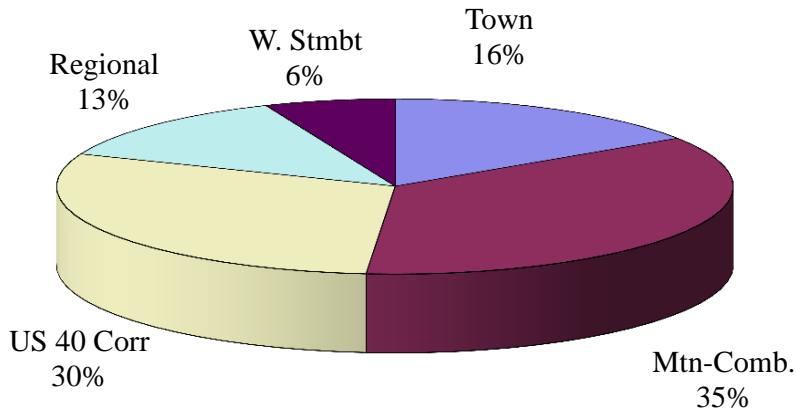

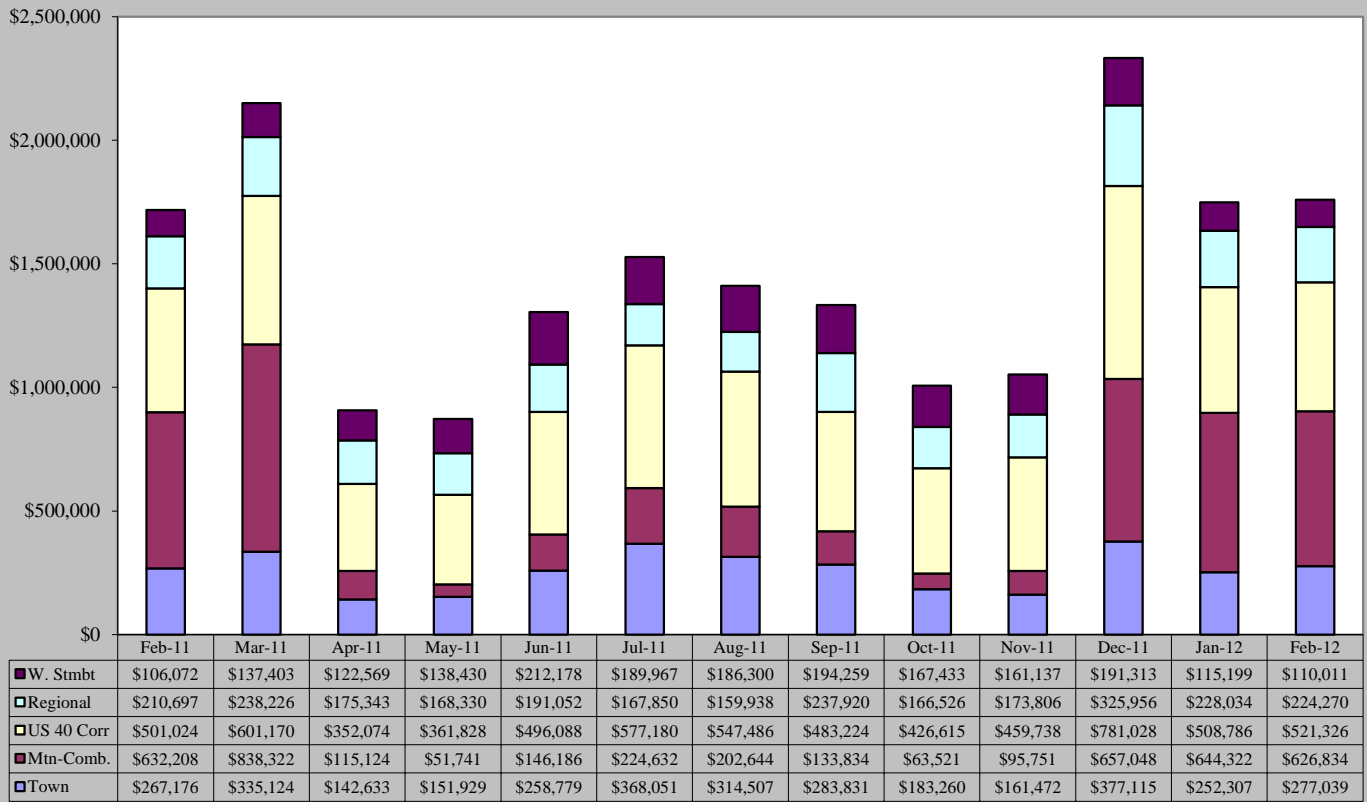




February 2012 Sales Tax By Area

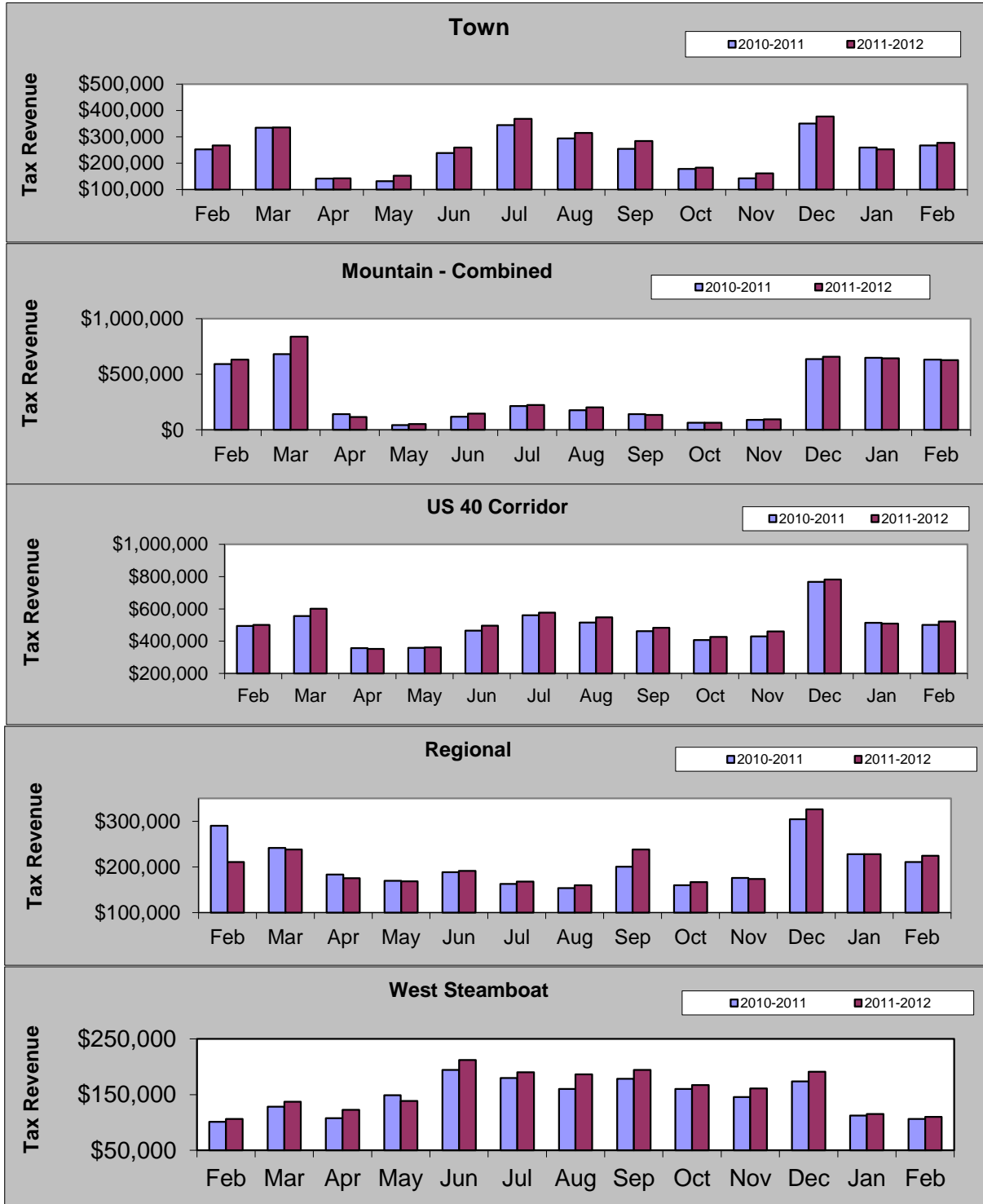

Building Use Tax

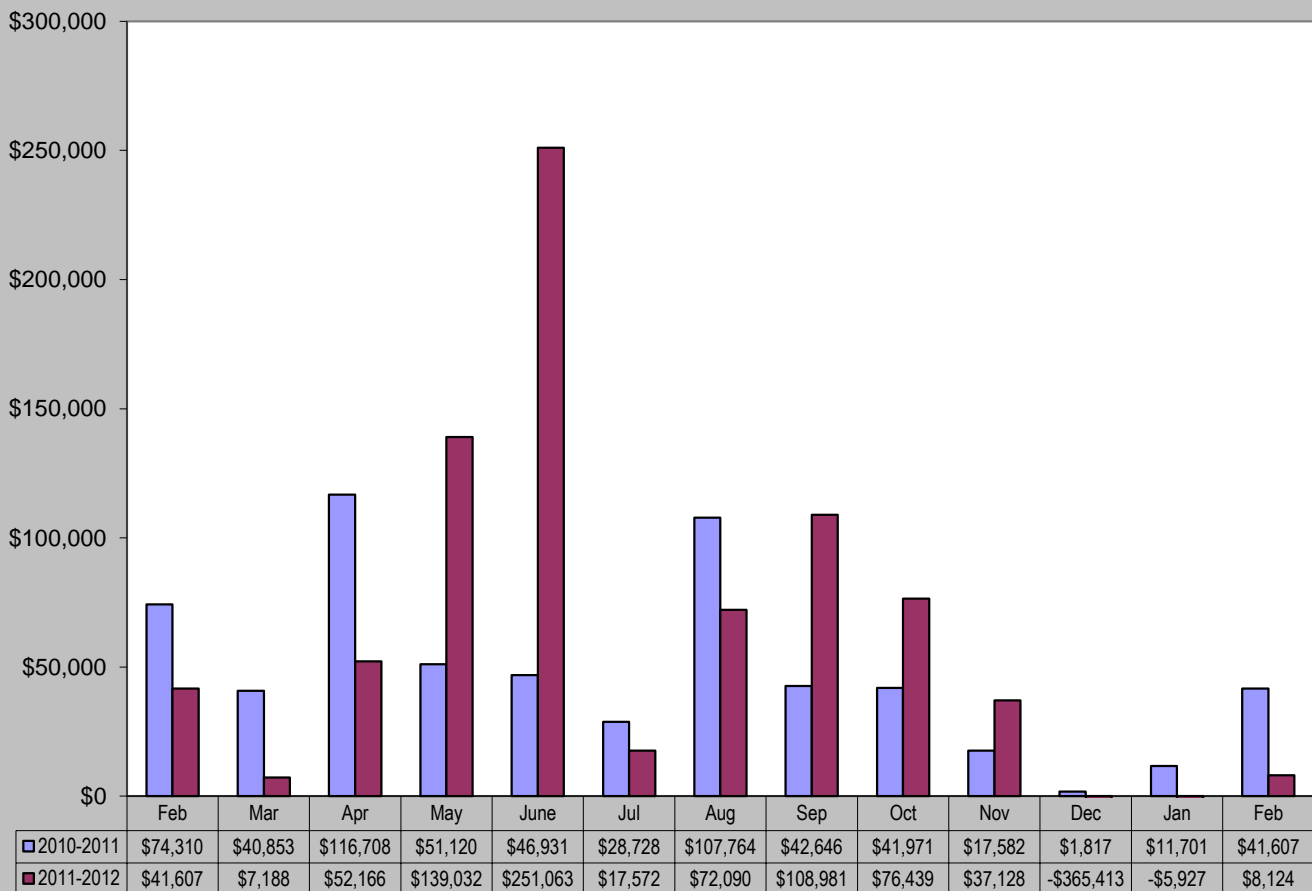
February 2012 Building Use Tax collections decreased 80.47% from February 2011.

Building Use Tax - 2010/2011 vs. 2011/2012



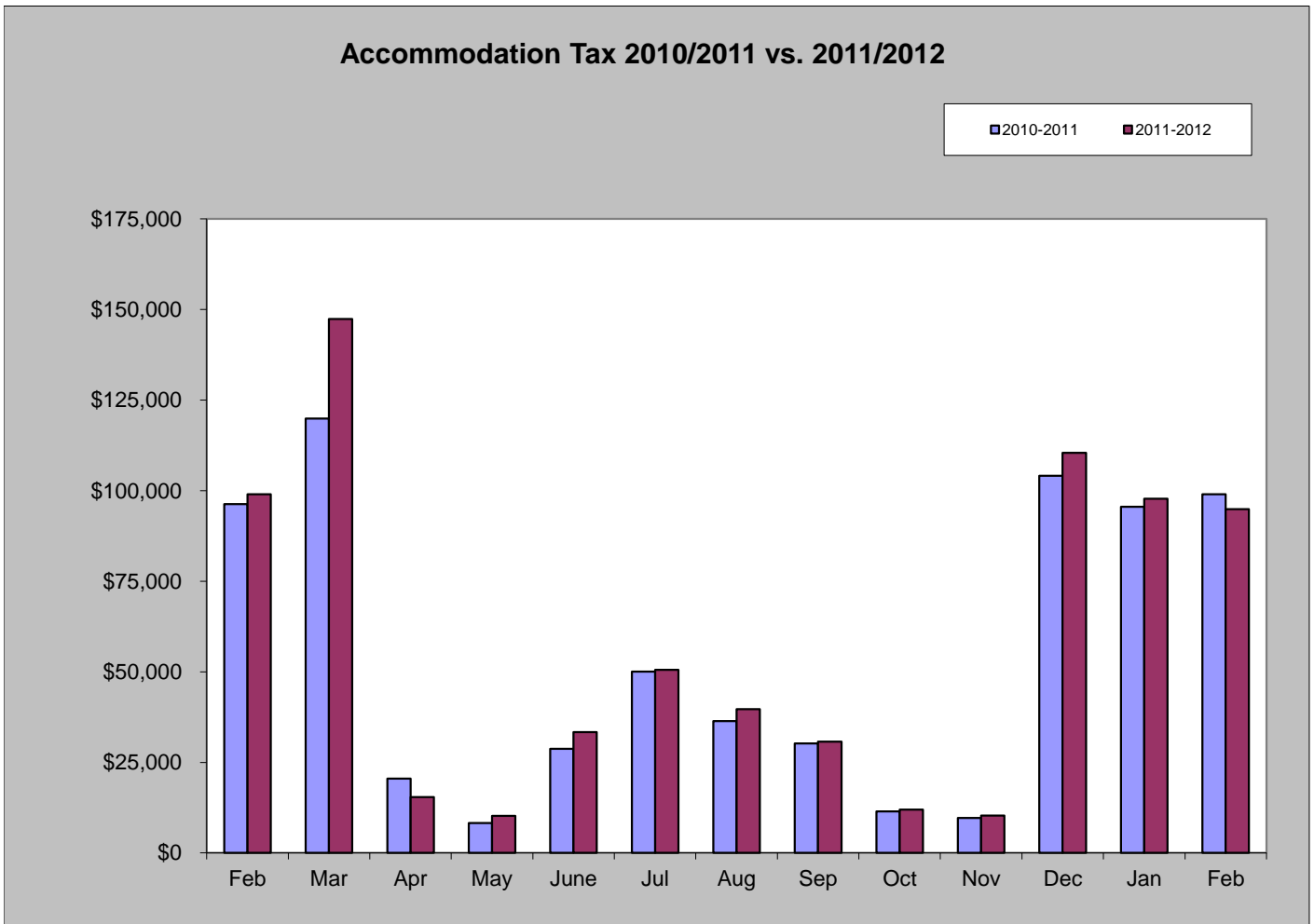
Accommodation Tax
