OFFENSES & STATUTES: HARASSMENT 18-9-111 CLASS 2 MISDEMEANOR

SYNOPSIS: THE PURPOSE OF THIS REPORT IS TO DETAIL THE CIRCUMSTANCES SURROUNDING HARASSMENT THAT OCCURRED AT THE 12TH HOLE AT THE SHERATON GOLF COURSE.

OBSERVATIONS: ON AUGUST 19, 2012 SGT. MCCARTIN AND I WERE DISPATCHED TO THE 12TH HOLE AT THE SHERATON GOLF COURSE ON AN ASSAULT. I TOLD DISPATCH TO HAVE THE REPORTING PARTY MEET ME AT THE CLUBHOUSE. UPON MY ARRIVAL I MET WITH THE REPORTING PARTY JOHN CHAPMAN (120276).

INTERVIEW WITH REPORTING PARTY: JOHN EXPLAINED TO ME THAT HE AND HIS PARTY WERE ON THE 12TH HOLE GETTING READY TO TEE OFF. JOHN SAID A FEMALE, DESCRIBED AS HAVING BLONDE HAIR, WEARING A PINK SKIRT, WHITE TOP, AND A WHITE VISOR, APPROACHED THEM. JOHN SAID THE WOMAN ASKED IF THEY HAD EVER PLAYED GOLF BEFORE. JOHN SAID HE TOLD THE WOMAN THEY HAD. THE WOMAN TOLD HIM THEY HAD LEFT THE FLAG IN THE CUP, TILTED. JOHN SAID THE WOMAN HAD AN ATTITUDE. HE TOLD THE WOMAN SHE DIDN'T HAVE TO BE A CUNT ABOUT IT. JOHN SAID THE WOMAN HIT HIM IN THE FACE. JOHN SAID HE CALLED THE WOMAN A CUNT AND AGAIN THE WOMAN HIT HIM IN THE FACE. JOHN TOLD ME HE GOT HIT ABOUT THREE TIMES BY THE WOMAN. JOHN SAID THE WOMAN TURNED AND LEFT.

I EXPLAINED TO JOHN CALLING THE WOMAN "A CUNT" WAS NOT THE PROPER THING TO DO. I TOLD JOHN THAT WAS PROBABLY THE REASON SHE HAD HIT HIM. I ASKED JOHN WHAT HE WANTED DONE. JOHN TOLD ME IF I COULD SPEAK TO THE WOMAN THAT WOULD BE FINE. JOHN DROVE ME OUT TO THE 12TH HOLE. HE POINTED OUT THE WOMAN WHO HAD HIT HIM. I TOLD JOHN I WOULD SPEAK TO HER. JOHN LEFT THE SCENE.

INTERVIEW WITH SUSPECT: MARY ELIZABETH EFFINGER (05/05/52). I CONTACTED MARY AND EXPLAINED TO HER WHY I NEEDED TO SPEAK TO HER. MARY EXPLAINED SHE HAS BEEN A MEMBER OF THE SHERATON GOLF COURSE FOR A LONG TIME. MARY SAID ON THE 11TH AND 12TH HOLE THE PARTY IN FRONT OF THEM, JOHN CHAPMAN, HAD LEFT THE FLAGS TILTED IN THE CUP. MARY SAID SHE WENT UP TO THE GROUP AND TOLD THEM ABOUT IT. MARY SAID THE MAN CALLED HER A CUNT. MARY SAID SHE HIT THE MAN. MARY EXPLAINED SHE HAD NEVER BEEN CALLED THAT NAME BEFORE. MARY SAID THE MAN CALLED HER A CUNT TWO MORE TIMES. MARY SAID SHE HIT HIM TWICE MORE AND LEFT. I EXPLAINED TO MARY THAT IT WAS NOT APPROPRIATE FOR HIM TO CALL HER A CUNT, SHE SHOULD NOT HAVE HIT HIM. I EXPLAINED TO MARY THE PROPER WAY TO HANDLE THE SITUATION WOULD BE TO CALL THE CLUBHOUSE AND SPEAK TO THE MANAGER AND HE WOULD HANDLE THE SITUATION. I TOLD MARY NO CRIMINAL CHARGES WERE TO BE FILED. IF SHE WAS INVOLVED IN ANOTHER SITUATION, SHE SHOULD WALK AWAY. MARY SAID SHE WOULD.
