July 2012 Taxes, Remitted in August 2012 Sales, Use, and Accommodation Tax Report


This City of Steamboat Springs Sales, Use, and Accommodation Tax Report examines tax collections for the month of July 2012, which were remitted to the City in August 2012.

Sales Tax

July 2012 sales tax collections decreased by 0.05% from sales tax collections for the month of July 2011. Year-to-date total sales tax collections are 1.99% higher than those of 2011 year-to-date.






Building Use Tax




Accommodation Tax




Local Marketing District - Air Service Sales Tax


