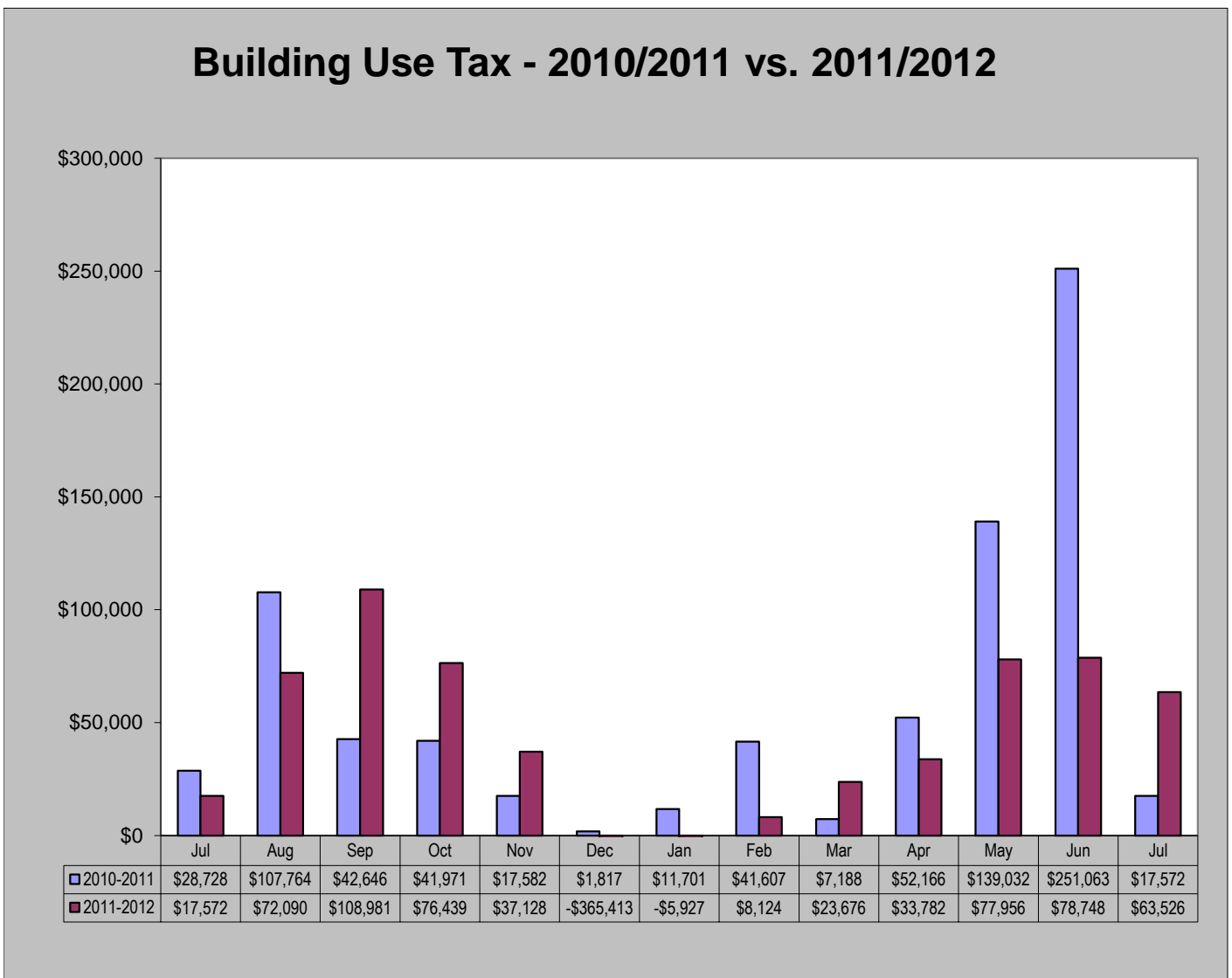
Building Use Tax

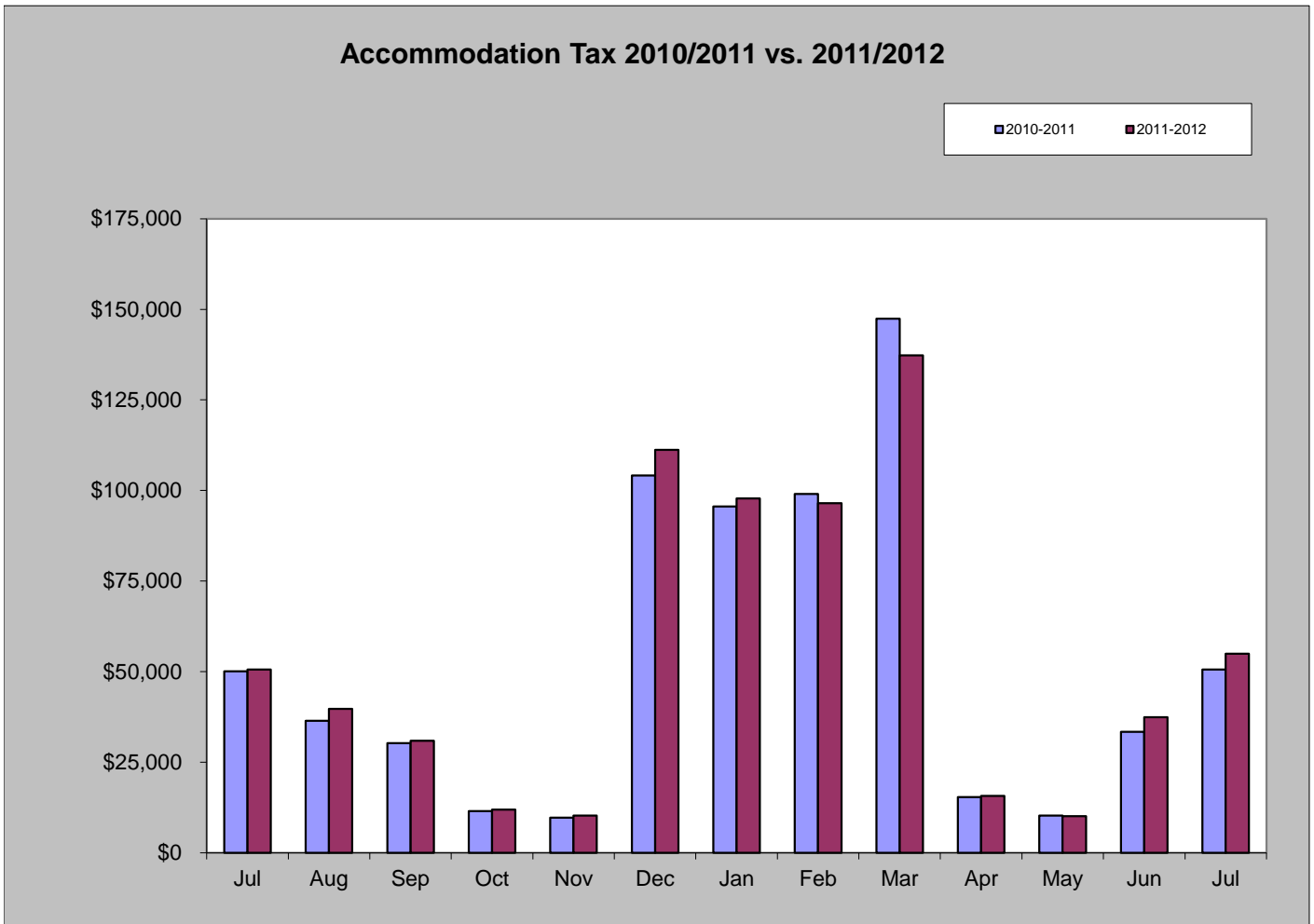
Accommodation Tax

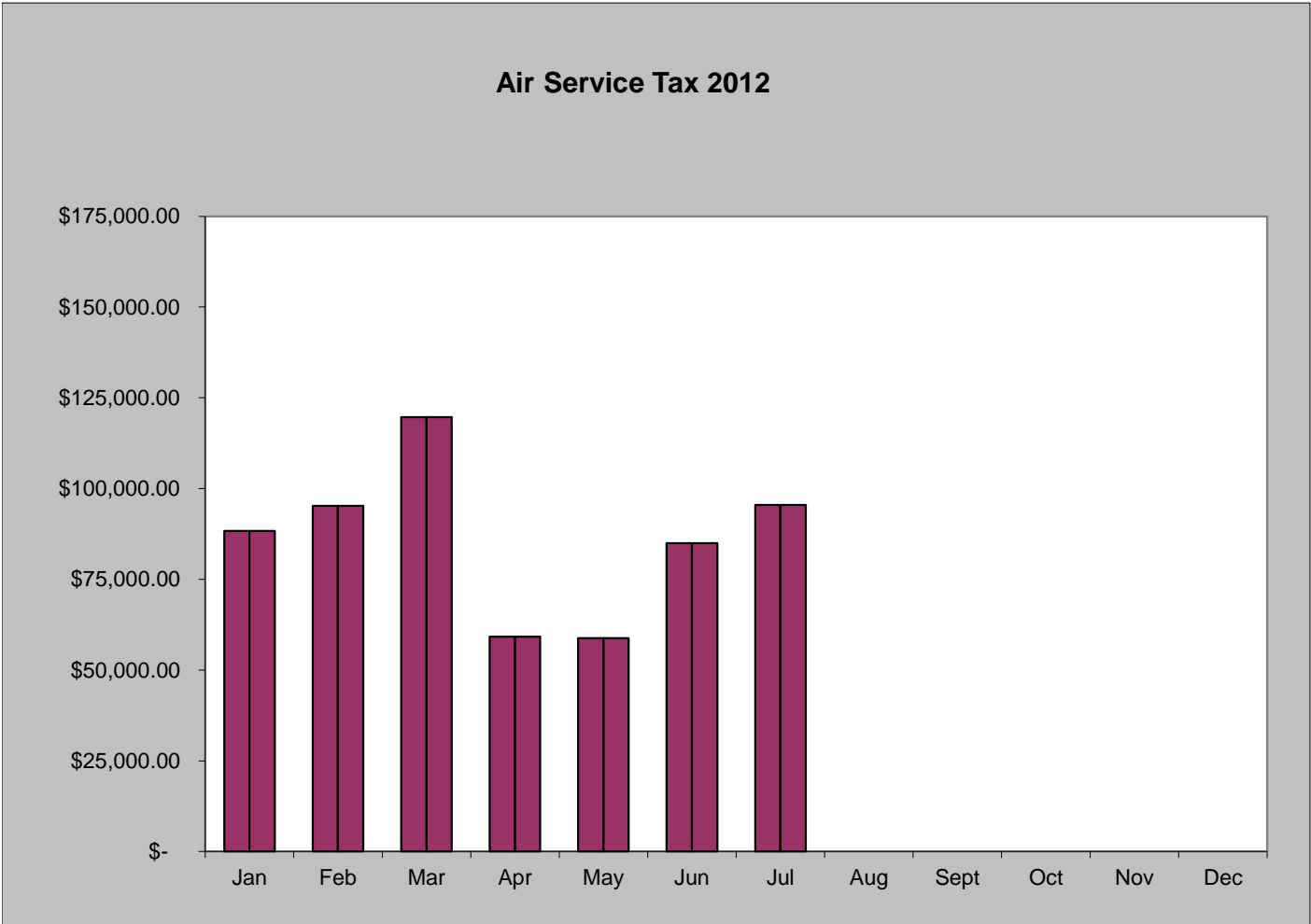


Local Marketing District - Air Service Sales Tax

July 2012 air service sales tax was \$95,455

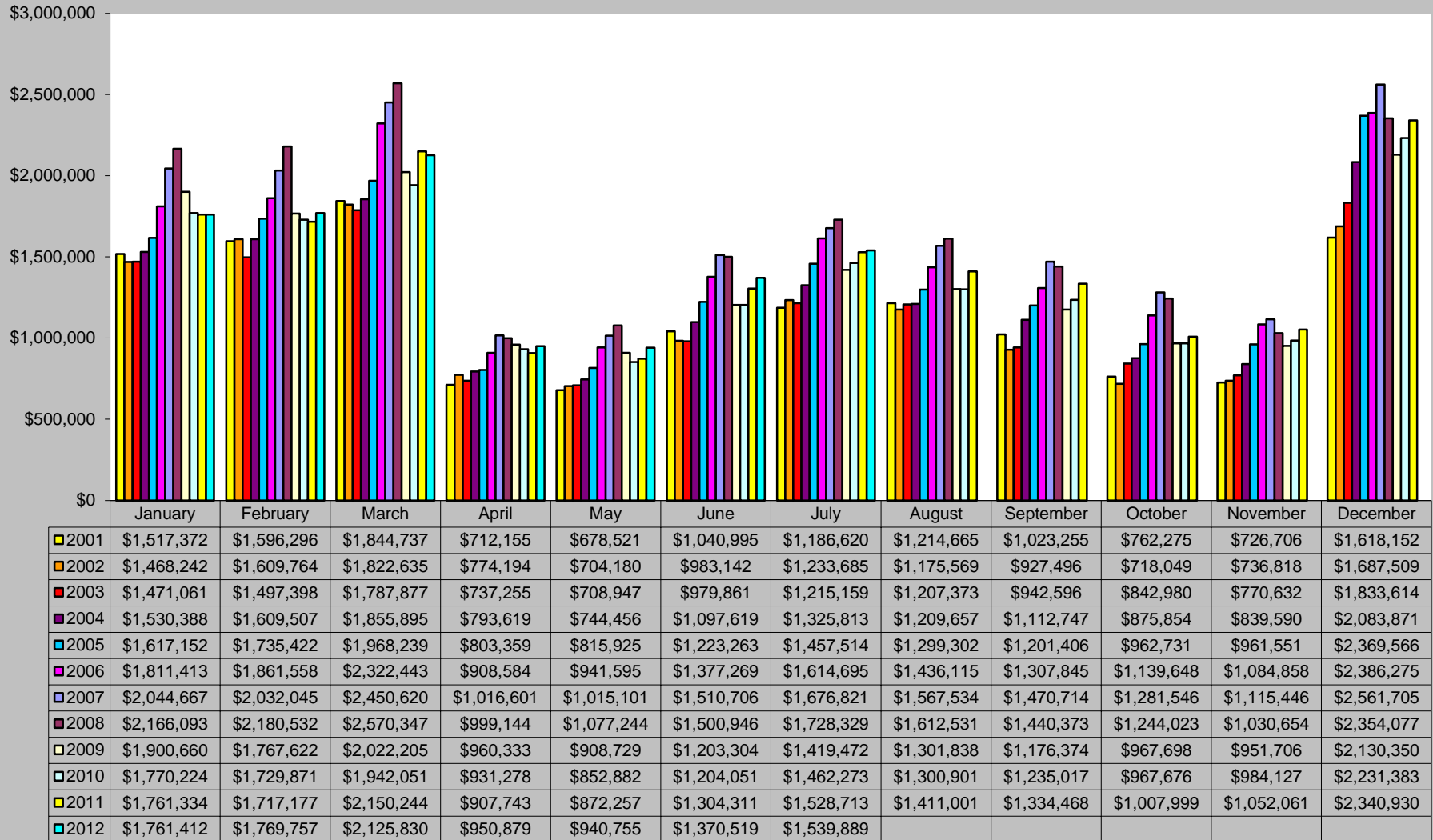

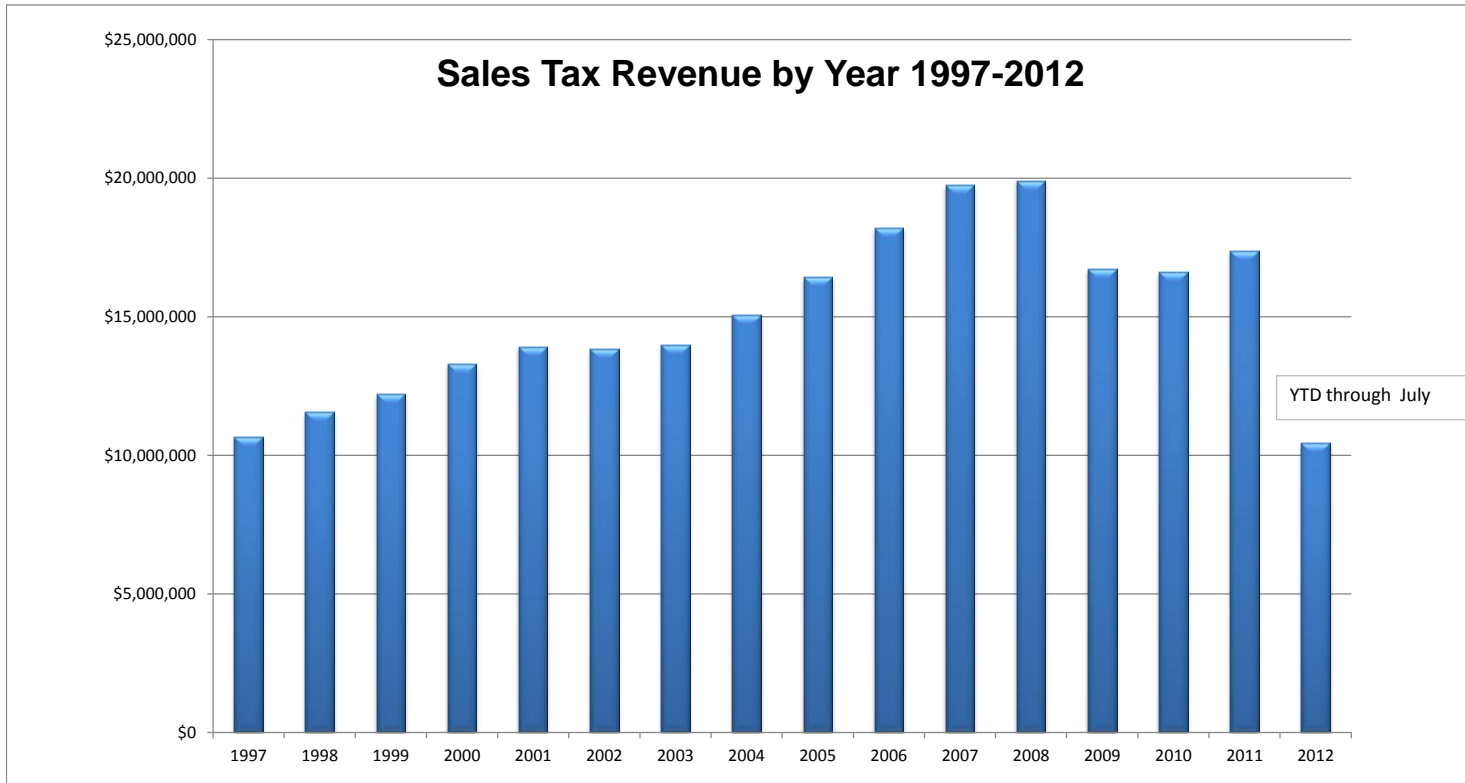
