




This City of Steamboat Springs Sales, Use, and Accommodation Tax Report examines tax collections for the month of August 2012, which were remitted to the City in September 2012.


Sales Tax



Building Use Tax


August 2012 Building Use Tax collections increased 32.66% from August 2011. Year-to-date building use tax collections decreased 36.61%.


Accommodation Tax


August 2012 accommodation tax increased 4.83% from August 2011. Year-to-date accommodation tax increased 0.02%.




Local Marketing District - Air Service Sales Tax
