By submitting an application the applicant understands and agrees that any information provided on this application or during interviews may be made available to the public.

Qualifications:

- 1. The applicant must be at least 18 years of age, and
- 2. The applicant must have been a registered Democrat in Routt County District 3 for all of the preceding year (registration prior to December 15, 2011), and
- 3. The applicant's primary residence must have been in Routt County District 3 for the preceding year.

Third, the reality of climate change demands we address the effects of the current drought and work with the Upper Yampa Water Conservancy District, State Engineers Office and the Colorado Water Conservation Board to mitigate the long term impacts to the agriculture and economic interests of Northwest Colorado.

4. Have you previously attended meetings of the Board of County Commissioners? Approximately how many and how often?

Yes, I have regularly attended Commissioners meetings over the past months, approximately 10 to 12 meetings, two to three times a month, depending on the agendas. I have attended numerous Oil and Gas permit hearings, presentations on water quality monitoring, the 2009 building code adoption as well as the 2012 county budget.
