This City of Steamboat Springs Sales, Use, and Accommodation Tax Report examines tax collections for the month of November 2012, which were remitted to the City in December 2012.

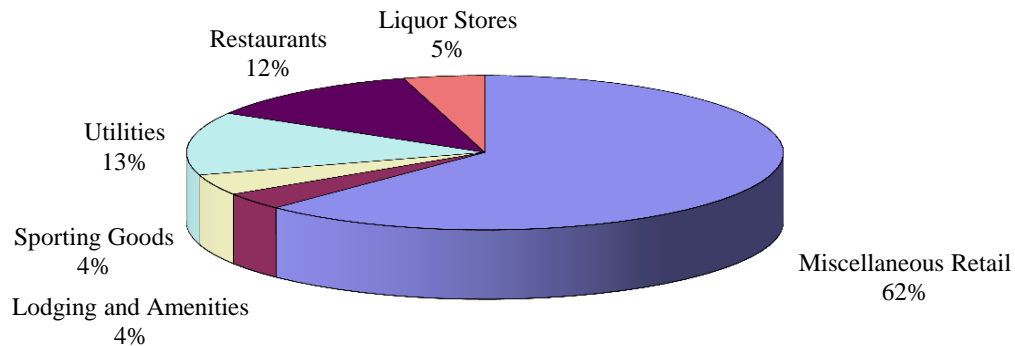
Sales Tax

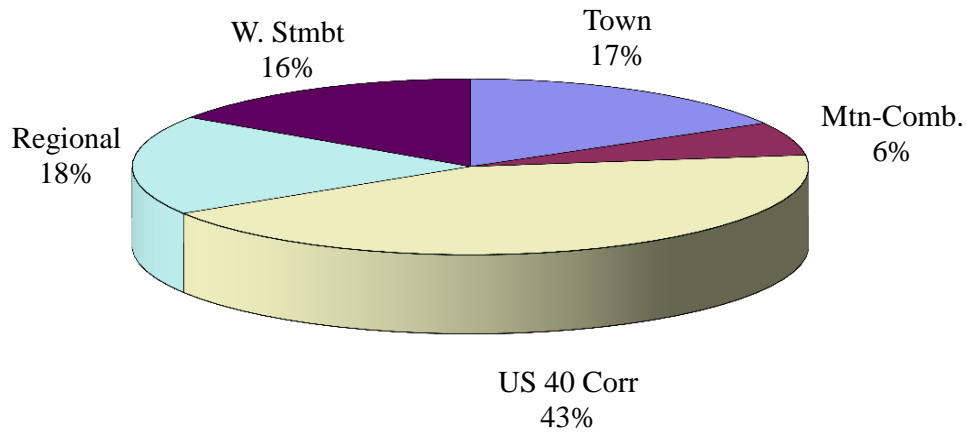

Building Use Tax

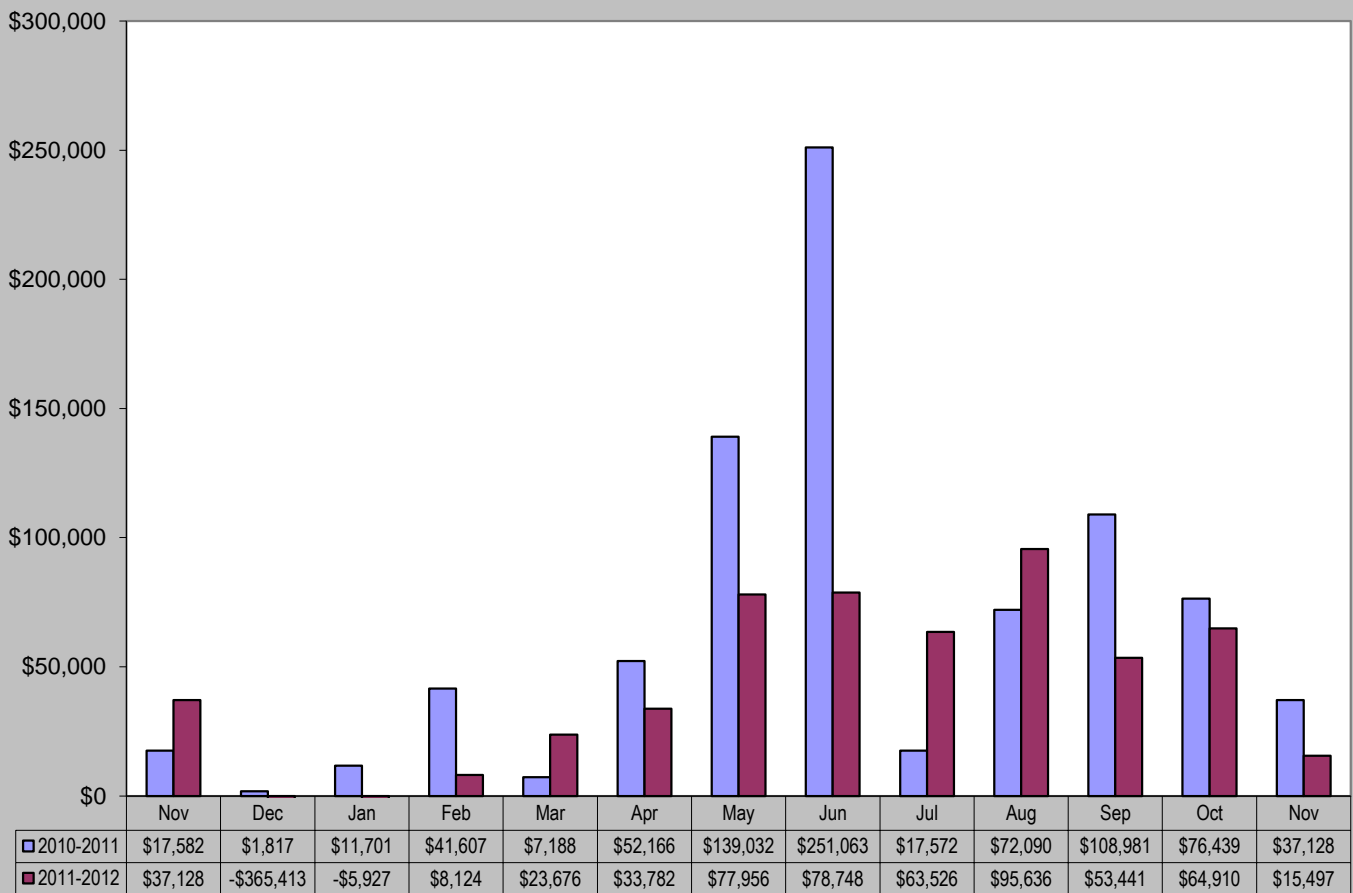
November 2012 Building Use Tax collections decreased 58.26% from November 2011.

Building Use Tax - 2010/2011 vs. 2011/2012



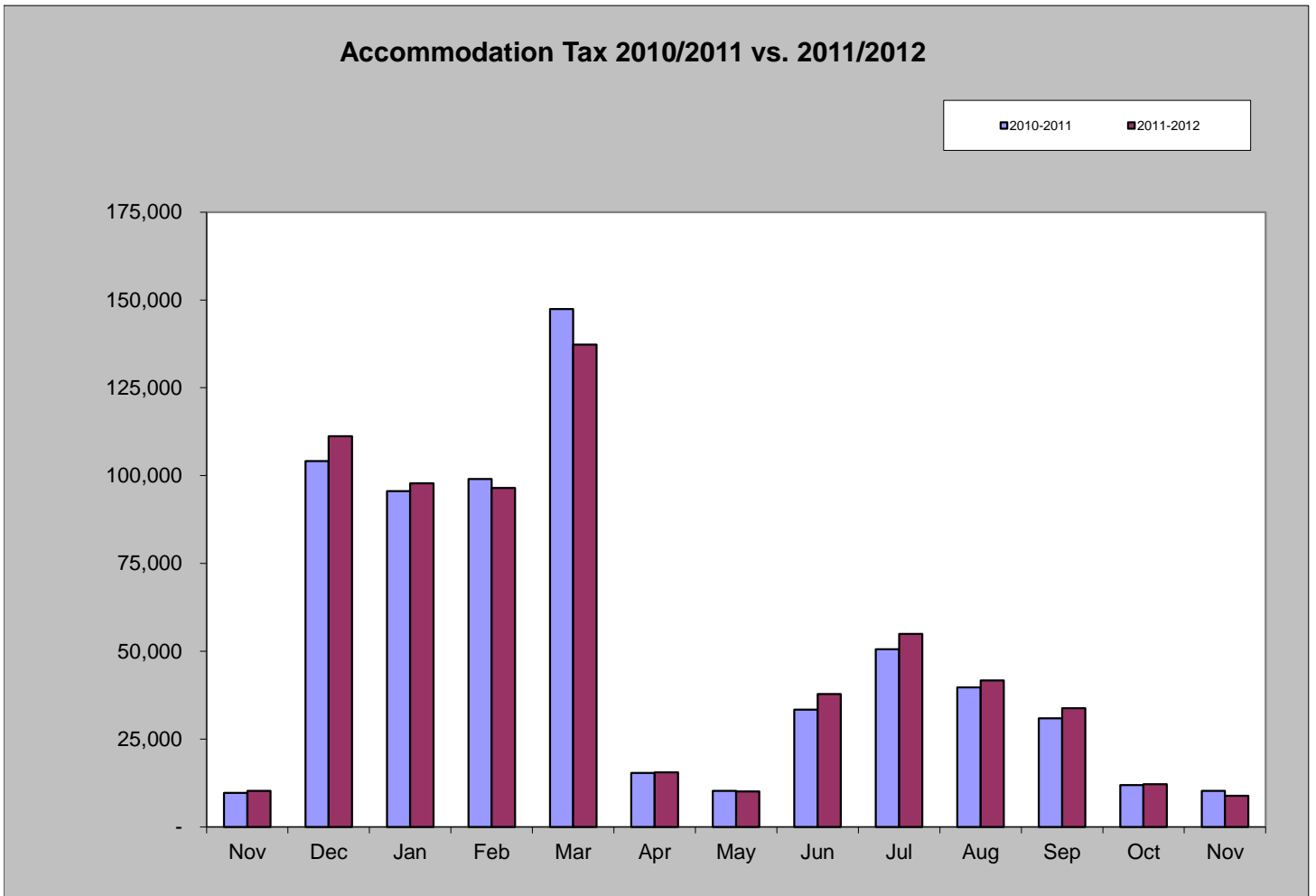
Accommodation Tax

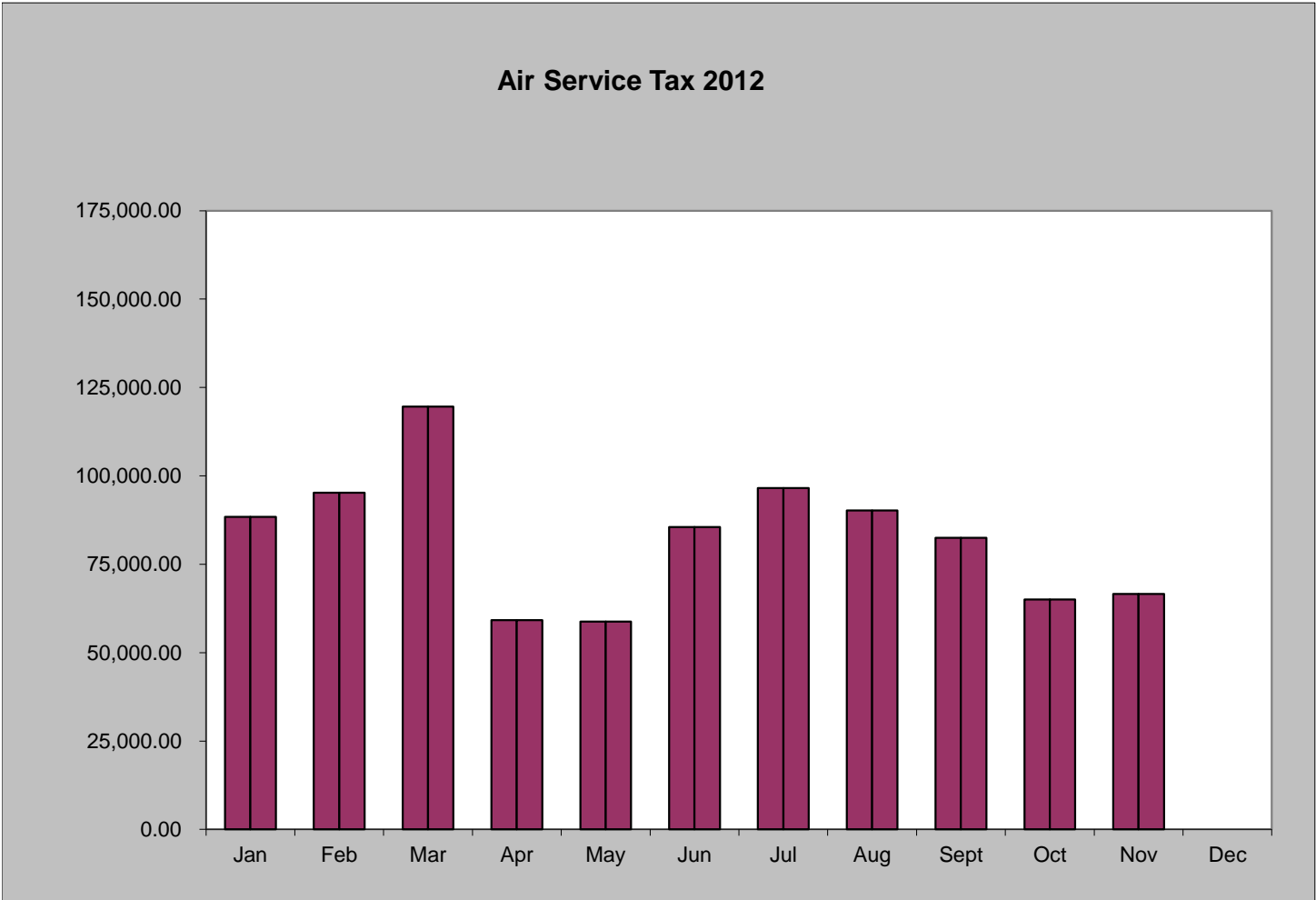


Local Marketing District - Air Service Sales Tax

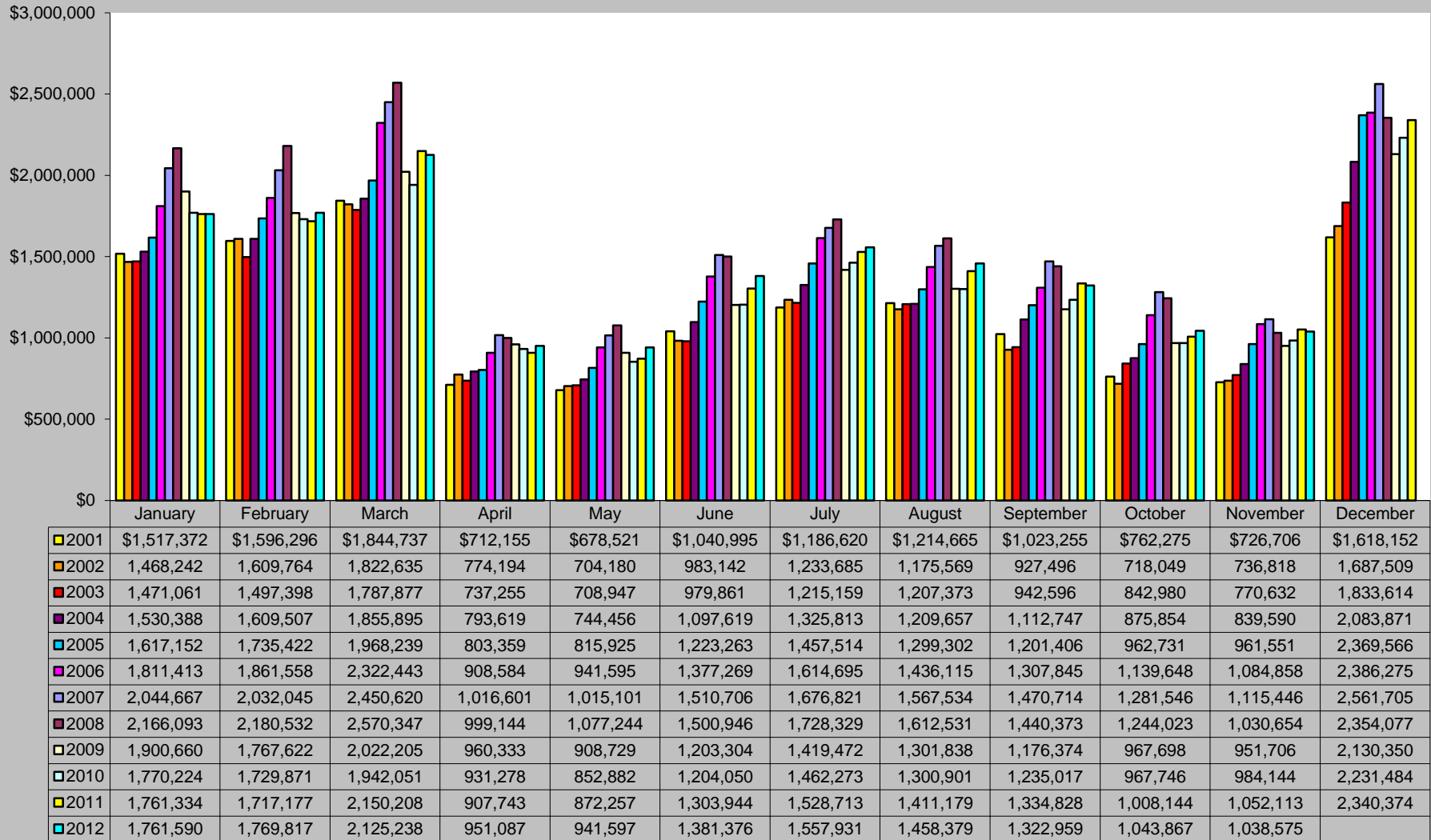

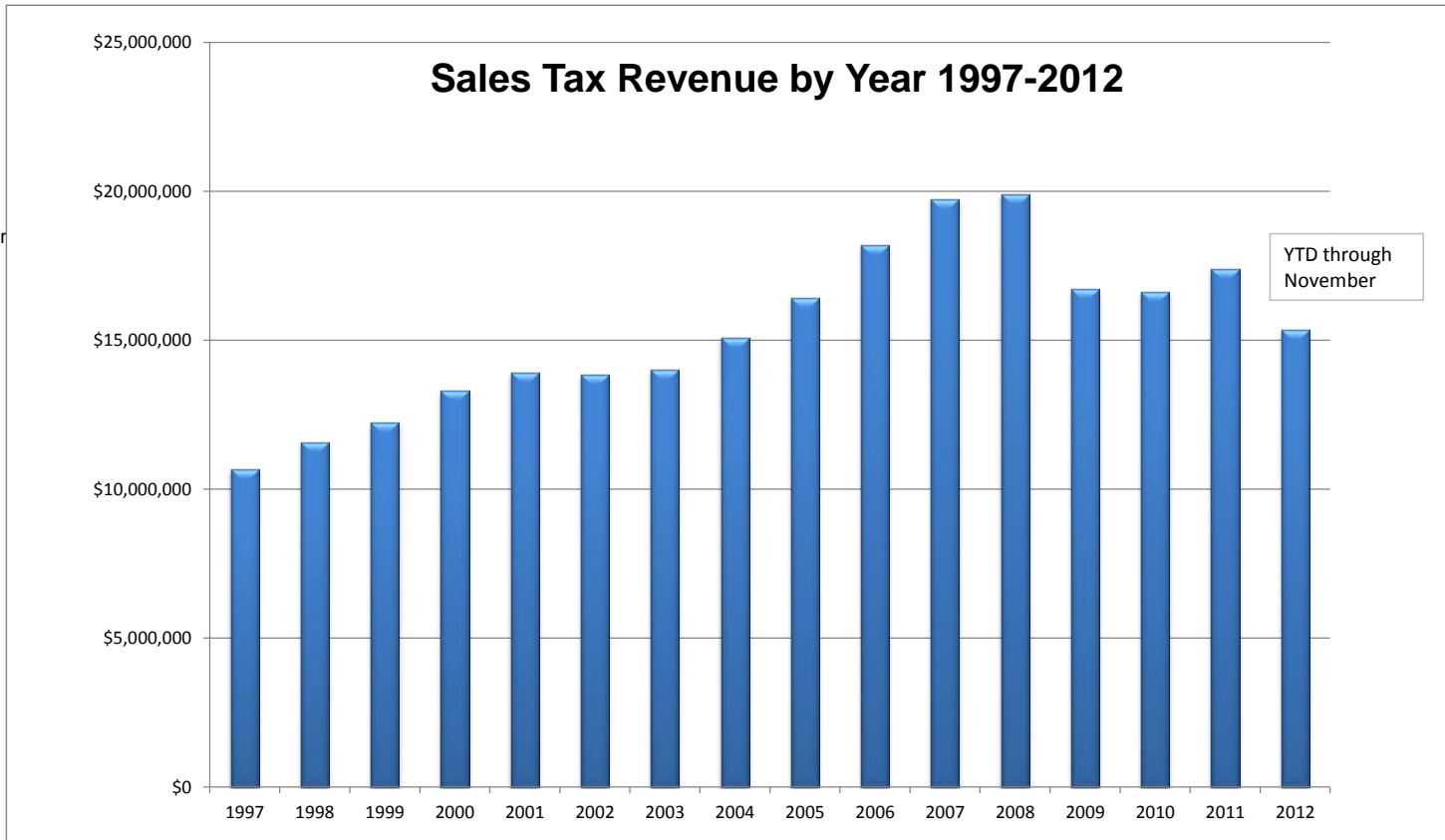
